#### **RESOLUTION NO. 2019-83**

## A RESOLUTION OF THE ALBANY CITY COUNCIL APPROVING CHANGE ORDER #2 TO CONTRACT #C18-10 2018 SANITARY SEWER REHABILITATION PROJECT AND BUDGET ADJUSTMENTS FOR CIP #32000

WHEREAS, recent communication with the US Environmental Protection Agency (EPA) indicated that the City of Albany is out of compliance with its annual requirements for sanitary sewer main rehabilitation under the 2014 EPA Consent Decree; and

**WHEREAS**, staff presented a recovery plan to the EPA to meet compliance requirements by June 2020 that includes accelerated rehabilitation of 9,500 feet of sewer main by September 2019; and

**WHEREAS,** the City awarded Contract #C18-10 to Ranger Pipelines Incorporated on June 4, 2018 for construction of the 2018 Sanitary Sewer Rehabilitation Project; and

**WHEREAS,** the City awarded Contract Change Order #1 (Contract #C18-10) to Ranger Pipelines Incorporated on February 16, 2019; and

WHEREAS, work completed under Contract #C18-10 and Change Order #1 have substantially satisfied the pipe rehabilitation requirements for 2019 under the 2014 EPA Consent Decree; and

WHEREAS, the City intends to continue its efforts to meet and exceed it annual pipe rehabilitation requirements under the Consent Decree; and

**WHEREAS,** the City proposes to expand Ranger Pipelines' scope of work to include rehabilitation of an additional 4,413 feet of sewer main pipeline as Contract Change Order #2.

**NOW, THEREFORE, BE IT RESOLVED,** that the Albany City Council hereby authorizes the City Manager to execute Contract Change Order #2 to Contract #C18-10 with Ranger Pipelines Incorporated in the not-to-exceed amount of \$1,624,870 from funding approved as part of this resolution; and

**BE IT FURTHER RESOLVED,** that the Albany City Council hereby approves a budget authorization for FY 19/20 to the Annual Sewer Rehabilitation Project (CIP #32000) in the amount of \$1,885,000 from the sewer capital fund (Fund 4002).
